OUR NEXT CLUB TRIAL

Sunday April 26th

Anchow Hill Lane

This is the excellent new venue that we used in May last year. It features amazing 360 degree views from the top of the hill.

See map below.

Take the Barton Highway out of Canberra.

Approximately 8kms past Hall, you turn right into Anchow Hill Lane.

This is a private road and it is essential that we all keep to the posted speed limit.

Follow this road 2.5 kms to it's end, turn left into Cameron Crook's property for the Trials site.

Entry Fees will be \$25 for Seniors, \$15 for Juniors, and \$40 for Families


One Event Licences will be available on the day at \$60 each.

You must be a TCC member to ride.

Unless Juniors have a Log Book, we cannot issue them with a One Event Licence.

Please be there in time for a 10am start. That means you need to be there at 9.30am.

One feature of this venue is an old quarry. Parents please take note. It's your responsibility to look after your littlies around the steep quarry walls.



Trials Park gossip

Representatives of TCC and ACTMCC have attended two meetings with the intention of resolving the issues in relation to the fees we have to pay when riding at Fairbairn Park.

Public Risk Insurance is at the centre of these discusions. I was still in New Zealand when the first meeting was held, however Daniel Gatt the CEO of MNSW did attend. Daniel was very positive in addressing this issue and urged our Clubs to work constructively together. Once we have agreed in principle to a fee structure, our suggestions have to go to Daniel for final approval.

Mick Rummery, Mark Walker and myself attended the second meeting with the ACTMCC hierarchy at the Italian Club in Forest. We reached a broad agreement on the principle, and are now working on the finer detail

Make no mistake in relation to this issue. Appropriate Public Risk Insurance is critical for the future of the Trials Club of Canberra.

When any TCC members ride at Fairbairn Park, there will be a cost involved. You will have to sign on the proper sheet, and you will be required to pay a fee.

Our negotiations are aimed at making those fees as minimal as we can.

Which is the right Licence for you?

You should look at a Licence as being a licence to ride and to be covered by Insurance, not just as a competition licence.

A **National Licence** (\$290 **Senior** or \$265 **Junior**) entitles the holder to compete in all forms of Motorcycle competition.

A **Restricted National Licence** (\$200 **Senior** or \$105 **Junior**) entitles the holder to compete in all Trials competition.

Each Licence is valid for 12 months from date of issue.

A One Event Licence (\$60) is only valid for Club Trial events on day of issue.

When we rode at Fairbairn Park (under the ACTMCC / MNSW Insurance agreement) you paid \$10 if you had a MA licence, or \$30 if you didn't have a MA licence.

If you ride your Trials bike in three Club Trials in twelve months, you're up for \$180 for three One Event Licences.

Simple maths will tell you that a Restricted National Licence is the most cost effective, and practical, way to go.

Another bonus is that you can also compete in National Open Trials, from the fun of the Glenmaggie Easter Two Day Trial right up to the (fun) Australian Trials Championship at Pacific Park in August.

As part of our month in New Zealand, I rode in the 2015 Ihatove Adventure Trial just south of Nelson on February 14th and 15th

Hobart based Kiwi Ken Hocking and I were the only two "international" entries. We were each able to hire bikes through Adventure Motos. Ken had a Jotagas, while I rode Stephen's custom built Montesa with a Sherco engine. Hybrid maybe, but absolutely fun to ride.

Our 'group of three' was completed by Ken's brother Peter whom I'd met at the 2014 Aussie Titles in Tasmania. Pete rode his Beta 125 and ended up showing both Ken and I how it should be done.
