#### 1. ANNOUNCEMENT:

Lower Mountains Motorcycle Club, hereafter called the PROMOTER, will conduct Round One of the NSW Moto-Trial Championships for solo competitors at, 1 Cheesmans Rd Cattai NSW 2756 on Sunday 28<sup>th</sup> June 2015.

#### 2. JURISDICTION:

- 2.1. The above-mentioned meeting has been authorised by Motorcycling NSW Limited (MNSW) who has issued the Motorcycling Australia Permit Number 7/15/61295 and is open to holders of current Motorcycling Australia National, and Restricted National competition licences.
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, the By-Laws of Motorcycling NSW and any Final Instructions.

# BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

## 3. ENTRIES:

- 3.1 Entries open forthwith and must be received by Wednesday 24<sup>th</sup> June 2015. Please call Kevin on 0401 431 629 to confirm you are entering, and ensure your name is placed on the score sheets before the day.
- 3.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Promoter, if such retention is approved by Motorcycling NSW.
- 3.3 Only entries received on the official entry form that is accompanied by the correct fee will be accepted.
- 3.4 Any entry monies paid on the day will be \$150 per rider.
- 3.5 The return of entry fees for any rider withdrawing from the meeting is at the discretion of the promoter.

# 4. INSURANCE:

- 4.1 National Capital Benefits Scheme provides basic cover for death and permanent disability.
- 4.2 Personal Accident and Ambulance Insurance is the responsibility of the individual.
- 4.3 It is strongly recommended that competitors give due consideration to taking out such insurance cover.

#### 5. MEDICAL SERVICES:

5.1 St Johns will be in attendance for the entire meeting.



#### 6. ENTRY FEE:

6.1 \$80-Senior \$40 – Junior \$120 – Family (1 senior and up to 3 Juniors ALL living at the same address) \$35–Minder

#### 8. GRADES OF COMPETITION:

8.1 The event will have sections set for the following rider grades, and appropriate grade lines:

**Expert** (Green Rider Name Plate, green section splits)

A (Red Rider Name Plate, red section splits)

**B** (Yellow Rider Name Plate, yellow section splits)

**C** (Blue Rider Name Plate, blue section splits)

**Clubman** (White Rider Name Plate, white section splits)

## 8.2 NSW Championship Classes will include:

Open Solo:

Those competitors, riding on a senior licence and who are graded in Expert and A grade, and choose to compete in those grades will be awarded points in the NSW Open Championship as follows: - best placed Experts will be awarded points in the NSW Open Championship followed by best placed A Graders etc. – nameplate colour, as grade entered.

**Open Junior:** 

Those competitors, riding on a junior licence and who are graded in A, B or C grade and choose to compete in those grades will be awarded points in the NSW Junior Championship as follows: - best placed Junior in the highest grade a Junior is competing in will be awarded first place points in the Junior Championship etc. – nameplate colour, as grade entered

Open Women

Those women riders who are graded in A, B C or Clubman grade and choose to compete in those grades will be awarded points, in the NSW Women's Championship, as follows: - best placed woman in the highest grade a woman is competing in will be awarded first place points in the NSW Women's Championship etc. – nameplate colour, as grade entered

Junior Women: Those women competitors, riding on a junior licence and who are riding machines that meet restrictions on engine capacity as specified in MOMS 23.6.1.2 run over the Clubman lines white nameplates

Veteran

(3 classes): Run over C Grade (Blue nameplate) lines for riders who are: 40-49; 50-59; 60+ on the day. Classes will be amalgamated into next younger class if less than 5 riders in class.

Masters:

Run over the B Grade lines for riders who are 35 years or older on the day.

Post Classic

Open to machines complying with GCR's 23.6.1.2 and 23E) Riders can nominate grade line to enter.

and Classic:

NOTE: This WILL NOT be a NSW Championship as the Denman MCC will run this as a separate State Championship.

Air Cooled

Mono:

Open to any machine complying with general GCR's with an air-cooled engine and mono shock rear suspension. Those competitors, riding an air cooled mono and who are graded in A, B, C and Clubman grade and choose to compete in those grades will be awarded as follows: best placed air cooled mono in the highest grade an air cooled mono's competing in will be awarded first place points in the air cooled mono etc. – nameplate colour, as grade entered.

Youth:

Those competitors aged between 16 and 21 years at the first day of competition (GCR's 23.5) - run over the B Grade lines.

Junior 7-12:

Those competitors, riding on a Junior Licence and who are riding machines that meet restrictions on engine capacity as specified in MOMS 23.6.1.2 run over the Clubman lines White Name plates.



#### 9. AWARDS AND PRIZE MONEY:

9.1 All championship classes will be awarded  $-1^{st}$ ,  $2^{nd}$  and  $3^{rd}$  place awards. In addition, all classes listed under 8.2 will be allocated points for their respective NSW Championship class with the exception of Classic & Post Classic.

#### **10. ENTRIES TO CONSTITUTE A CLASS:**

- 10.1 To constitute a class, the number of contestants entered and competing in each class shall be five (5).
- 10.2 Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards, will be at the discretion of the Promoter, subject to Motorcycling NSW approval.

#### 11. COMPETITION FORMAT:

- 11.1 The number of sections and laps will be advised on each day.
- 11.2 Clubman and Junior will ride anywhere within section boundaries and/or may be restricted further.
- 11.3 Expert, A, B, C, Masters, Post Classic, and Veteran riders will be further restricted.
- 11.4 Scoring will be as per GCR 23.12.3.2 -Trials.
- 11.5 There will be a 90 second time limit applied for all competitors per section.

### 12. MACHINES AND RIDERS:

- 12.1 All machines entered must comply with the current GCR's for MOTO-TRIAL competition.
- 12.2 Multiple entry of the one machine in the same class of competition is not permitted.
- 12.3 A competitor may finish the trial on a machine other than their own, provided they have first obtained the approval of the MA Steward.

#### **13. RIDING NUMBERS:**

13.1 All nameplates on machines MUST comply with the GCR rules pertaining to trials machines. Headlights are not acceptable.

#### 14. GRID POSITIONS: N/A

#### **15. RIDERS BRIEFING:**

- 15.1 A riders briefing shall be held prior to the commencement of the trial on the day.
- 15.2 All competitors and minders MUST attend the rider's briefing.
- 15.3 Riders briefing sign-on sheets may be used, and must be signed after the riders briefing by the competitor and minder as proof of attendance.

## 16. DRUGS AND OR ALCOHOL TESTING:

16.1 By order of Motorcycling NSW, random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.

#### 17. CODE OF CONDUCT:

17.1 All competitors, officials and parents are reminded of the Motorcycling Australia CODE OF CONDUCT (as stipulated on page 356 of the 2015 GCR's) which is a guide to appropriate behaviour at all motorcycle competition meetings. This CODE OF CONDUCT applies to this meeting and shall be enforced.

## **18. TIMETABLE:**

- 18.1 Competitors to present their motorcycle to the Scrutineer by 9.40am on Sunday when machines will be impounded until the start at 10am.
- 18.2 Competitors must present their competition license (and log book for juniors) to the Race Secretary to confirm their entry before the rider's briefing.
- 18.3 While entries received on the day will incur a penalty, all riders and minder entries must be received and processed before the rider's briefing. Riders and minders entries will NOT be accepted after this time.
- 18.4 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed as 8am on each day. The completion of the meeting for the official, observer, rider, minder and support crew being the completion of all racing.

## 19. CIRCUIT DESCRIPTION:

19.1 See points 11, 15 and 18. circuit, laps and sections will be advised at the riders briefing each day of competition

22.1 All machines must comply with the requirements of the GCR's.


### 23. PAYG WITHOUT HOLDING:

#### **24. SPECIAL NOTES AND WARNINGS:**

- 24.1 There will be no lunchbreaks.
- 24.2 No bikes to be ridden in the area during the event other than by competitors and officials.
- 24.3 No animals permitted. (Guide dogs exempted).
- 24.4 Any change of entry details on the morning of the trial will be subject to a \$20 Fee.
- 24.5 Start time will be 10am
- 24.6 No competitors are allowed to enter the sections before the start of the event.
- 24.7 There is no on site camping. Camping sites are available at Pacific Park, and powered camp sites for caravans and trailers. Full facilities are available with bathroom, shower and laundry facilities.

- 24.9 There is no catering, electric power or fuel available on site. Nearest shops and service station are in Pitt Town .

## 2. DEFINITIONS In this declaration:
