BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THE RULES, REGULATIONS AND INSTRUCTIONS AS SET OUT BELOW.

1. ENTRIES:

- 1.1. Entries are open forthwith and will close at 5pm on Wednesday 26th September 2012.
- 1.2. In the event of postponement or abandonment of the meeting, all entry fees will be refunded.
- 1.3. Only entries received on the official Entry Form and accompanied by the correct fee will be accepted.
- 1.4. **NOTE: - THE RETURN OF ENTRY FEE FOR ANY RIDER WITHDRAWING FROM THE MEETING IS AT THE DISCRETION OF THE ORGANISING CLUB.**

2. INSURANCE:

- 2.1. Ambulance Insurance is recommended for all competitors.
- 2.2. It is strongly recommended that participants consider taking out weekly benefits insurance and personal accident cover.

3. A First Aid person will be on site.

4. ENTRY FEE:

- 4.1. Two Days Adult - \$40 for club members. Non members \$45 includes \$5 day membership for both days.
Single day \$25 plus \$5 day membership. Family \$50 (One adult rider and two children of the same family).
- 4.2. Cheques are to be made payable to the Coonabarabran Motorcycle Club. Please do not send cash in the mail.
ANY FEES FOR DISHONOURED CHEQUES WILL BE THE RESPONSIBILITY OF THE ENTRANT.
- 4.3. Entries on the day will attract an additional fee of \$25

5. CLASSES OF COMPETITION

The club has three Grades, 1 (Yellow), 2 (Blue) and 3 (Green). Grade 1 being for the more experienced riders, down to Grade 3 for Clubmen and beginners. Please indicate on the form which grade you wish to enter.

6. AWARDS

1st, 2nd and 3rd in each class, plus Best Twinshock, Best Lady Rider and Best Junior.

7. TRIAL FORMAT

- 7.1. The number of sections and laps to be completed will be announced at rider's briefing.
- 7.2. There will be a time limit for completing the course on each day.

8. MACHINES AND RIDERS

- 8.1. All machines must comply with the current GCR's for Moto Trials Competition.
- 8.2. Only one rider per machine will be permitted.
- 8.3. Competitors must present themselves dressed for competition, including helmet, gloves and boots, which must all be in good condition.
- 8.4. Bikes must be presented for scrutineering between 8am and 9.30am on Saturday morning.
- 8.5. Tyres shall be of a Universal Trials Pattern.

9. NUMBER PLATES

Riders will be issued with a riding number, in their nominated grade colour, at sign on.

10. RIDERS BRIEFING

A Riders Briefing will be held prior to the commencement of the trial, which all Competitors must attend.

12. FACILITIES AND SAFETY.

ACKNOWLEDGEMENT OF RELEASE AND ASSUMPTION OF RISK

WARNING – This is an important document which affects your legal rights and obligations. Read it carefully and do not sign it unless you are satisfied that you understand it. If you have any questions please ask one of our representatives or seek legal advice.

ACKNOWLEDGEMENT OF RISK, INJURY AND OBLIGATIONS

I **ACKNOWLEDGE** that the activity I am to undertake is a **DANGEROUS** activity and that by participating in and/or observing it I will be exposed to certain risks. I, the undersigned: **HEREBY ACKNOWLEDGES AND UNDERSTAND** that whilst participating and/or observing activities related to a "CMCC" event:

- I may be injured, both physically or mentally, and may be killed;
- My personal property may be lost, stolen or damaged;
- Other persons participating in such activities may cause me injury or may damage my property;
- I may cause injury to other persons or damage their property;
- The conditions in which the activity is conducted may vary without warning;
- I may be injured or die or suffer damage to my property as a result of the negligence or breach of contract of others;
- There may be no or inadequate facilities for treatment or transport for me if I am injured;
- I assume the risk of and responsibility for any injury, death or property damage resulting from my participation and/or observation in the event;
- Any claim I make against "CMCC" will result in a claim being lodged with "CMCC" insurers and/or the obtaining of legal advice. Such action will result in "CMCC" incurring costs that may not be recoverable, even if the claim is without merit;
- No clause herein that is void or voidable shall affect the other terms and conditions of this agreement.

RELEASE AND INDEMNITY GIVEN TO ORGANISERS

IN CONSIDERATION of being granted permission to participate in the "CMCC" event, I **AGREE TO RELEASE AND INDEMNIFY** "CMCC", its principals, property owners, servants and agents as follows:

- I participate and/or observe in the activities at my own risk and responsibility;
- I absolve, release, indemnify and hold harmless "CMCC", its principals, Property owners, servants and agents, from all liability and in respect of all and any proceedings, actions or claims which may be made by me or on behalf or by other parties howsoever arising for or in respect of or arising out of any injury, loss, damage or death caused to me or my property whether by negligent act or omission, breach of duty, breach of contract, breach of statute or in any way whatsoever arising out of or in any way in respect of or in connection with my participation or observation in the activities of the event;
- In the event I make a claim against "CMCC", I hereby agree to pay "CMCC" forthwith upon demand any reasonable legal or other costs incurred by "CMCC" arising from such claim and I agree that such monies shall be forthwith recoverable from me as a liquidated sum in any court of competent jurisdiction;
- I enter into this agreement on my own behalf and on behalf of my executors, administrators, assigns and any minors for whom I am responsible at any time during my participation and observation of the event.

I **ALSO AGREE THAT** in the event that I or any minor for whom I am responsible is injured or has property damaged, lost or stolen, will bring no claim, legal or otherwise, against "CMCC" in respect of that injury, loss, theft or damage.

Before signing this document I **ACKNOWLEDGE THAT** I have read and understood it and know that it affects my legal rights.
